At the accident

- Try to remain calm. Call a lawyer right away.
- Use your cell phone to call the police and medical personnel if needed. They may only respond in case of serious injury.
- If the other driver passed a red light or stop sign, please tell the police. If the other driver hit you in the rear, passed a yield sign, or made a U-turn, please tell the police. If you have any question or doubt that you may have been at fault, then simply say you were in a motor vehicle accident, and leave it at that.
- Do not move any vehicles until police arrive—unless not doing so creates a greater danger of injury or traffic requires it.
- Do **NOT** make statements about your responsibility to other drivers, witnesses, the police, or insurance representatives. Assist the police with their official report.
- Use this form to obtain accident information.

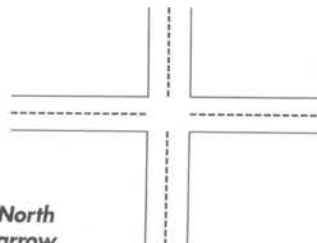

- If you or passengers receive serious injuries, ask to be transported to a hospital in an ambulance. If you have car insurance, you have at least \$50,000 per person of medical and hospital coverage. In all instances, obtain medical treatment as required ASAP. Tell medical personnel about **everything** that is physically wrong with you.
- Report the accident to your insurance agent ASAP. Do **NOT** speak to the other driver's insurance representatives.
- Within a day or two, make an appointment with your family doctor. Report all injuries and symptoms and comply with your doctor's instructions.
- Retain copies of all medical bills and related accident expenses.

\$3,000,000

A man fell and was injured when he walked into an elevator shaft and there was no elevator there. He suffered two broken legs. Through our efforts, we were able to recover \$3,000,000 for the injured person.
