Examples of some of our verdicts and settlements

\$3,222,000—Subway accident case

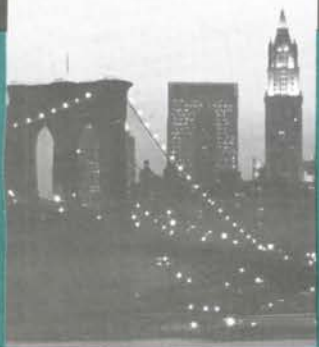
A man suffered a seizure that caused him to jump in front of an oncoming subway train. He had to have his legs amputated below the knees. We recovered a verdict of \$3,222,000* in spite of being advised by a well-respected judge in the case to settle the case for \$90,000.

**This amount was reduced on appeal because the verdict was so huge.*



\$2,500,000—Rape case

A child was raped due to inadequate security controls in the Bronx building she lived in. We contended that the high-rise apartment complex in Harlem and its managing agent had inadequate control of master keys that controlled the building elevators, and had subpar security. Three youths entered the elevator in which our client was riding and used a copy of the elevator passkey to send the elevator to the basement. They then dragged the girl to an adjoining building in the complex and into another elevator. They used the key again to send the elevator to a top floor and jammed it while they raped her. The settlement was reached before trial and resulted in a total payout of \$2,500,000.
