### The Case of David Kuchinsky Settlement \$4,625,000

David Kuchinsky, age 41, a limousine driver, was driving on Atlantic Avenue, near the intersection at Rockaway Avenue, in Brooklyn. While he was decelerating due to traffic, his vehicle was struck from behind by a van. Kuchinsky sued the driver and the owner of the van. Kuchinsky alleged that the driver was negligent in the operation of his vehicle.

Kuchinsky suffered pain which stemmed from his back and neck. He further claimed that his back pain was radiating to his legs. He underwent several surgeries. After extensive physical therapy he resumed work; however, he quickly stopped working, because his injuries did not permit the prolonged periods in which he was seated in his limousine.

He sought recovery of over \$238,338 for past lost earnings, an unspecified amount for future lost earnings, and damages for past and future pain and suffering, etc.

The parties negotiated a pretrial settlement. Kenneth Wilhelm settled the case for \$4,625,000. The money Mr. Kuchinsky received was tax free.

### The Case of Marek Chilinski Settlement \$2,500,000

Marek Chilinski, age 24, fell through a hole while on United Baking Company's premises. He fell about 14 feet; he was a welder at the time of the accident. There was plywood planking over the hole that did not hold his weight. He was taken to the hospital and remained in the hospital for about 23 days.

Marek suffered multiple facial fractures and had his jaw wired. He also had plates and screws implanted into the facial fractures. He was out of work for about 11 months and then did return to work on a full-time basis.

Kenneth Wilhelm settled the case for \$2,500,000; jury selection was to begin shortly. The money Mr. Chilinski received was tax free.
